Major 7-06-0421-01 "Jurisprudence"

The program of the entrance test for applicants for the Master degree program in the Major 7-06-0421-01 "Jurisprudence " was developed on the basis of standard curricula for academic disciplines of the Bachelor degree programs: -"General Theory of Law"; - "Civil Law"; - "Civil process". The content of the program is of a complex, systemic, interdisciplinary nature and is focused on identifying general professional and special knowledge and skills acquired at the Bachelor degree prorgams in applicants, which are necessary for admission to the magistracy. The program determines the list of questions, the knowledge of which is necessary for passing the entrance test, and includes a list of recommended literature, which contains regulatory, scientific, educational and other materials. An applicant for the Master degree program, admitted to passing an entrance test in a specialty, must show a high level of theoretical and practical training, knowledge of legal terminology and skills in working with theoretical sources, knowledge of current legislation, understanding of the processes taking place in the state and society, competence in matters of related to the legal support and management of the state and society, assessing the effectiveness of the activities of public and non-state actors, as well as the ability to apply their knowledge to solve specific research and applied problems. The entrance test is conducted orally by tickets. The mark of the examine is set on a ten-point scale.

List of questions for the entrance examination in the specialty 1-24 80 01 ''Jurisprudence''
