## Silk Road Sunshine Public Fund 2018 Scholarship Programme Agreement

The Silk Road Sunshine Public Fund was established by the Silk Road Chamber of International Commerce (SRCIC) in 2016 to support the education of students in Silk Road countries.

This year the fund will support 30 students to complete 4 years undergraduate study in one of the many prestigious universities in Xi'an. The fund covers tuition, accommodation, insurance and RMB1500 stipend per month for 10 months for the students.

Students are required to read the following terms carefully and sign ahead of the formal application.

- I. **University you are admitted in (please tick one):**
  - Northwestern Polytechnical University (NPU)**
  - Chang'an University (CHD)**
- II. Academic duration: 4 years
- III. Program: Undergraduate (Bachelor's degree )
  - NPU: Business Administration
  - CHD: Mechanical Engineering
- IV. Teaching Language: English
- V. Silk Road Sunshine Fund Coverage: Application, tuition, accommodation, medical insurance, and RMB 1500 stipend per month for 10 months (February-July, September-December) each year.
- VI. Requirements for applicants:
  1. Age: 18-30.
  2. High School Transcripts (top students at school).
  3. Diploma: High School Diploma or above.
  4. TOEFL80 or IELTS 6. (NPU)  
TOEFL68 or IELTS 5.5. (CHD)
  5. Non-criminal Certificate (with Chinese Translation).
  6. Physical from Entry-Exit Inspection and Quarantine Bureau.

**VIII. Selection and Enrollment Process**

1. Qualified applicants can apply on the website of these two universities application system.
2. NPU and CHD will have the final decision in the selection process.
3. NPU and CHD offer admission letters to successful applicants.

**IX. Sponsorship Termination Conditions:**

1. All students' documents must be accurate and authentic. Any falsification will lead to an immediate expulsion of the student from the beneficiary list and the SRCIC reserves the right to pursue legal action.
2. The student fails to abide by the laws and regulations of The People's Republic of China and the host university.
3. The student publishes negative, slanderous, libel or unsubstantiated comments about SRCIC or The People's Republic of China.
4. The student must be medically cleared of any serious or potentially hazardous illness, and must provide certified medical clearance to SRCIC before participating in the program. If the student is found to have a preexisting serious illness after participating, it could result in termination of the program.
5. Two or more courses failed at the semester exam.
6. The student fails to pass HSK4 after 2 years' study.
7. Students with a recorded demerit or serious warning.

8. The student fails to pass the yearly scholarship qualification examination.
  9. Any student requiring a study extension is to be self-funded during the extension period.
  10. The student fails to support 3 SRCIC's events.
  11. The program does not permit temporary leave from school/university or drop out of school/university or transfer to other major/school/university. These actions will be regarded as a withdrawal from the program. The student are required to reimburse all previous program costs before leaving the school/university.

The undersigned student fully understands and agrees to the above terms and hereby signs the agreement of his/her own free will.

This agreement shall come into force on the date of the signing and shall remain valid for four years thereafter.
